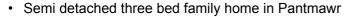

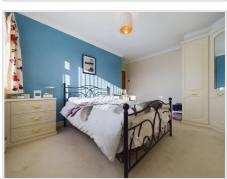

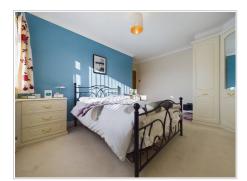
## **Utility Room**
