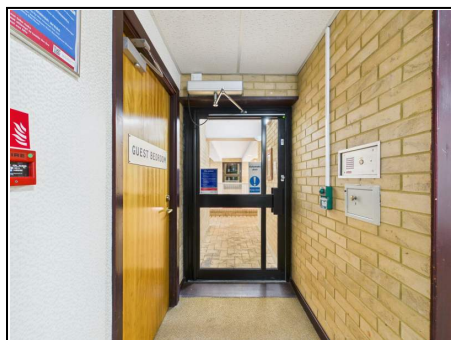
Communal Entrance Hall

Bright and welcoming entrance hall with managers office, guest bedroom (pre bookable) laundry room and lifts to upper floors. Hallway off to ground floor properties.



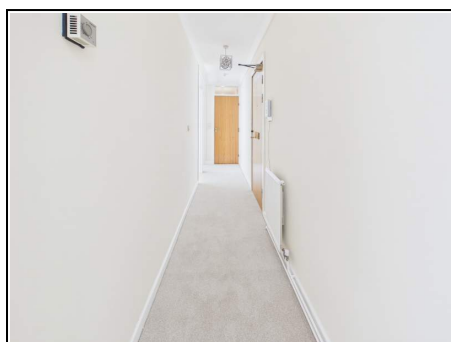
Laundry Room

Communal laundry facility.



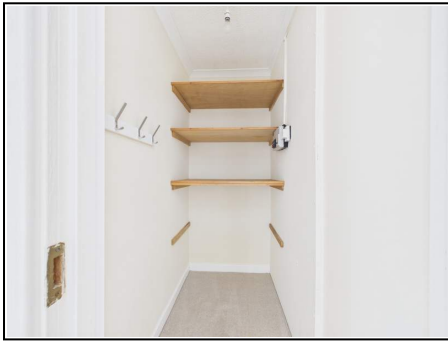

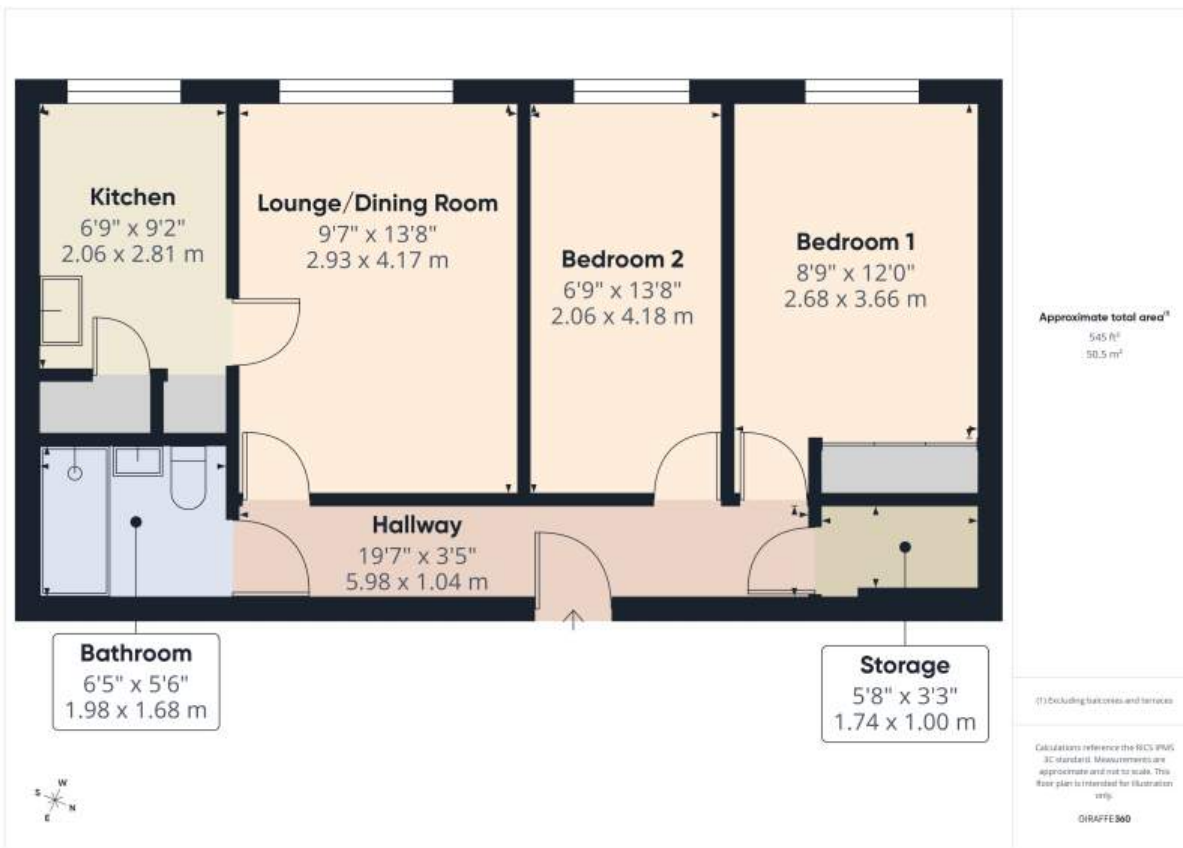
